DOCUMENT SUBMISSION REQUIREMENTS

a. **FurPAL's Declaration, Release, and Waiver Form:** This form must be completed and signed by the passenger

b. **Health Certificate:** A valid health certificate for the pet dog, issued by a licensed veterinarian. Only Health Certificate issued within three (3) days from the date of the actual flight departure and must state that dog is "tick free". Despite said Health Certificate, Philippine Airlines, Inc. reserves the right to deny acceptance to the pet dog should it appear sick, injured, listless, unhealthy, distressed, and/or aggressive at the time of check-in and/or boarding.

c. **Vaccination Certificate:** A valid vaccination certificate for the pet dog, demonstrating up-to date vaccinations. The vaccination certificate must be valid for at least one (1) year from the date of the flight

d. **Bureau of Animal Industry Local Shipping Permit:** This form is free of charge and can be accessed at <https://nvqsd.bai.gov.ph>

Philippine Airlines, Inc. (PAL) reserves the right to offload me and/or my pet dog at any stage of the journey for any violation of the FurPAL terms and conditions (e.g. health issues, aggressive behavior, and/or incomplete documents).

Philippine Airlines, Inc. (PAL) has the final discretion whether a flight diversion for purposes of giving emergency care to my pet dog is necessary, and only under extreme exigent cases, and that in making such assessment, PAL shall prioritize the overall flight safety and security of both passengers and crew.

I shall reimburse Philippine Airlines, Inc. (PAL) for any & all damages that my pet dog may cause to PAL's personnel, agents, aircraft, and property, as well as for any & all costs of flight diversions in the exigent cases when my pet dog will be in need of emergency care.

I shall be exclusively liable for any & all damages that my pet dog may cause to the person and property of third parties, including, but not limited to my co-passengers, and the flight and cabin crew, and hold PAL free and harmless from such damages;

I release Philippine Airlines, Inc. (PAL), its directors, employees, agents and affiliates from any and all liabilities and damages that I, my heirs, and authorized representatives may incur in relation to flying my pet dog in the Subject Flight, including, but not limited to any injury or death to my dog caused by changes in cabin pressure, air turbulence, and such other cabin conditions, and any and all damages caused by third parties, and/or my negligence, or due to any undeclared and/or underlying pre-existing health condition of my pet dog.
