

## **Detailed requirements for pass holders entering Singapore from Group 4 or all other countries/regions**

They must comply with the following:

1. **Take a COVID-19 polymerase chain reaction (PCR) test\* **within 72 hours before departure****
  - Pass holders who have [recovered from COVID-19](#) are also subject to this requirement.
  - Pass holders need to present a valid negative test result, in English and from [laboratories that are internationally accredited or recognised](#) by the respective countries' or regions' government, to enter Singapore. The test memo must also state these details:
    - Test result
    - Date of COVID-19 PCR test
    - Pass holder's name and either date of birth or passport number, as stated in their passport. If the particulars on the memo are not in the passport (e.g. memo states identification number, instead of passport number), the pass holder must produce the relevant identification documents for verification.
2. **Take an on-arrival COVID-19 test\*** in Singapore
  - Please [register and pay for the pass holder's test](#) (\$160 including GST) **before he/she arrives in Singapore**. Otherwise, he/she may be denied entry into Singapore. Your subsequent entry applications may also be rejected.
3. **Serve a 14-day Stay-Home Notice (SHN)** at SHN dedicated facilities (SDFs)
  - Once they arrive, they will be informed of the location and sent directly to the facilities.
  - For pass holders who [meet certain conditions](#), you can request for them to serve SHN at a place of residence during the entry application, instead of SDFs.
  - For pass holders staying in dormitories: After the 14-day SHN, they must undergo an [additional 7-day testing regime at designated facilities](#).
4. **Take a COVID-19 swab test\*** before 14-day SHN is over
  - The pass holder will be notified of the test appointment details by SMS.
  - During the entry application, you will be asked to pay for the following:
    - Pass holder's SDF stay (\$2,000 including GST)
    - Swab test (up to \$200 including GST)

**Note:**

- **Pass holders entering Singapore from 7 May 2021, 23:59 hours:** Must serve a 21-day SHN at SDFs. During their 21-day SHN, they will take 2 COVID-19 swab tests\*.
- **Those who have not completed their 14-day SHN by 7 May 2021, 23:59 hours:** Also subject to the 21-day SHN. They must serve the remainder of their 21-day SHN at their current SHN accommodation.
- **Pass holders with travel history to Bangladesh, India, Nepal, Pakistan, Sri Lanka, South Africa or United Kingdom:**

Currently required to serve a 21-day SHN at SDFs. Those who have not completed their 21-day SHN **by 7 May 2021, 23:59 hours**, must complete their 21-day SHN at their current SHN accommodation. During their 21-day SHN, they will take 2 COVID-19 swab tests\*.

- **Pass holders with travel history to Fiji or Vietnam:**
  - **In the last 21 consecutive days before entry and arrive in Singapore from 7 May 2021, 23:59 hours:** Must serve a 21-day SHN at SDFs. Those with a [suitable place of residence](#) have the option to serve the last 7 days of their SHN at the residence. During their 21-day SHN, they will take 2 COVID-19 swab tests\*.
  - **Those who have not completed their 14-day SHN by 7 May 2021, 23:59 hours:** Also subject to the 21-day SHN. Those who are currently serving SHN at:
    - o Place of residence can continue to serve the remainder of their 21-day SHN at the residence.
    - o SDFs can serve the remainder of their 21-day SHN at SDFs. Those with a [suitable place of residence](#) have the option to serve the last 7 days of their SHN at the residence.

**Charges for 21-day stay at SDF: \$3,000 including GST (excludes COVID-19 test charges)**

\* Children 6 years old and below this year are exempted from the COVID-19 tests.

## Registration and payment instructions for on-arrival COVID-19 test

Pass holder's mode of entry into Singapore	Cost of on-arrival test (including GST)	How to register and pay for the test?
Air	\$160	Use <a href="#">Changi Airport's eService</a> to register and pay for the test <b>before the pass holder arrives in Singapore.</b>
Land	\$160	<p><b>On arrival</b>, the pass holder must register and pay for the test at the checkpoint using any of these modes:</p> <ul style="list-style-type: none"> <li>• Cash in Singapore dollars</li> <li>• NETS</li> <li>• MasterCard or VISA</li> </ul> <p>You may need to reimburse the pass holder. Find out <a href="#">who is responsible for the test cost</a>.</p>
Sea	\$160	Use <a href="#">MPA's eService</a> to register and pay for the test <b>before the pass holder arrives in Singapore.</b>

## Conditions for pass holders to serve the last 7 days of their SHN at a place of residence

During the entry application, you can request for pass holders to serve the last 7 days of their SHN at a place of residence, instead of SDFs, if they fulfil **all of these conditions**:

- Occupy the place of residence alone or only with household members, including any foreign domestic workers, with the same travel history, arrival date and SHN duration.

**Note:** Place of residence does not include hotels.

- Spent the last 21 consecutive days in any of these places before entering Singapore, and did not travel to other countries/regions:
  - Fiji
  - Vietnam
