**SECTION I - GENERAL RULES**

SPECIAL AIRPORT LOUNGE FACILITIESMABUHAY LOUNGES(A) The services and facilities provided at the Mabuhay Lounges are:

- (1) Reading materials
- (2) Telephones (only calls made locally are free of charge)
- (3) Lavatory facilities
- (4) Refreshments and alcoholic beverages

C

(B) PAID LOUNGE [N]FEE ACCESS AT THE AIRPORT

- (1) Lounge access can be purchased at the PR Airport check-in counter only. Selling and collection will be done at the PR counter.
- (2) Paid Lounge Access are available at the following routes and rates:
  - (i) London - MNL GBP 30
  - (ii) Vancouver - MNL CAD 45
  - (iii) Vancouver - JFK CAD 45
- (3) The following tickets are eligible for [C]paid lounge fee access
  - (i) Revenue tickets on economy class
  - (ii) Revenue tickets regardless of cabin class such as industry discount (ID), Agent Discount (AD), company convenience (CC), and Award Tickets (BP) booked on economy.
- (4) The following Passengers are Entitled to Lounge Access Free of Charge:
  - (i) Platinum card holders regardless of class of service (Plus travelling companions regardless of class of service)
  - (ii) Legitimate/Revenue Business Class Passengers
  - (iii) Mabuhay Miles Members
    - (1) Million Milers (Plus 1 travelling companion regardless of class of service)
    - (2) Premier Elite (Plus 1 travelling companion regardless of class of service)
    - (3) Elite
    - (4) Special Handling from the office of the chairman, office of the deputy CEO, office of the President and COO, and office of the operations department.
  - (5) Non-Revenue ticket holders travelling on Business class such as chairman and immediate family members, members of the PAL board directors, PAL senior vice presidents.
- (5) Lounge access may be sold 3 hours prior estimated time of departure (ETD) of the flight
- (6) Lounge access are nonrefundable, non rebookable and non-transferable
- (7) Rate above is per person. Children aged 8-11 will be charged the same rate as adults. Infants below 2 years of age will be accepted for free. Both infant and children must be accompanied by 1 paying adult.
- (8) Eligible customers must present their boarding pass with the lounge indicator upon entry to the lounge.
- (9) Rate is available for a one-time entry with a maximum 3 hours at the lounge.
- (10) Guests must read the terms and conditions of the local lounge provider at the airport of origin.

(C) Exception to the admission requirements at the discretion of Carrier's Station Manager on the day of flights Prominent public persons or celebrities whose presence in the public area might cause undue disruption and/or congestion leading to unsafe and/or uncontrolled environment for the passenger and/or for other passengers.

(D) Admission to the lounge is subject to the regular operating hours of the Lounge and shall be subject to the lounge's maximum seating capacity.
